April Meeting – Membership Auction

Meeting Summary - March 2015

The President called the meeting to order 7PM Thursday, MAR19th with 25 members present. The Treasurer's report was presented, noting an ending balance of \$1514.73. The Treasurer's report and February 2014 meeting minutes were unanimously approved.

Old Business:

- J. Hepler provided updated Membership Medal status. Penny Press provided trial strikes that were passed out for member inspection. Two major changes are required; one was known before the meeting the other was discovered by a member (Penny Anderson) during the meeting. Changes required are as follows:
 - The encased Kennedy Half shows too many design details and somewhat obscures struck medal elements.
 - Penny Press recommended that we encase 1/2 T. ounce .999 fine silver blanks instead of 40% silver Kennedy halves. Motion made, seconded, and discussed. Results: 24 were for the motion and one against...motion carries.
 - Encased silver blanks to be stuck with the RACC design previously approved (page 4).
 - This change increases cost by \$8.00 per medal.
 - New members joining after March 2015 must have two years of consecutive membership to receive Member Medal (cost covered by RACC)
 - The trial strike contained a spelling error (highlighted on page 4) consequently, the die must be remade. This will be discussed at the April meeting.
- RACC officer elections are coming soon. Up for election are the offices of President and Secretary.
 - The election will take place at the May 2015 meeting
 - Let one of the current officers know if you are interested in filling one of these positions. We already have candidates for each open office but more candidates are always welcome.

 - Randolph Grimes became the first RACC Life Member
- Family Memberships were discussed. According to RACC By-Laws, a Family Membership costs \$18.00 annually but there is currently no limit to the number that can be included. A motion was made to change the By-laws to limit Family Membership as follows;
 - The cost of the Family Membership is unchanged at \$18.00 per year and will include a primary member and one other family member.
 - Additional family members can be added at \$6.00 each.
 - The motion was seconded and unanimously approved.



RACC Auction Rules & Guidelines

Auction Rules

- 1. Auctions will be held at regularly scheduled meetings.
- 2. Any item of numismatic interest may be submitted for auction including; coins, currency, tokens, medallions, scrip, etc.
- 3. Members only may submit items for auction.
- 4. A List of auction Lots must be provided to the Secretary by the due date provided by the Secretary. This is necessary so that the list can be published and sent to the membership so they can plan their bid if desired.
- 5. No more than 15 items/Lots may be offered per member unless approved by the auctioneer.
- 6. 95% of the proceeds of each item go to the submitting member and 5% rounded to the nearest 10 cents will go to RACC. The money earned by RACC will go into the general operating fund.
- 7. Charges for auctioned item/lots will be the hammer price.
- 8. Identical items, listed separately will be offered to all bidders at the bid preceding the winning bid.
- 9. Additional guidelines are listed in Article IX of the RACC By-laws.

Additional Guidelines

 Keep in mind that you are dealing with novice to expect collectors when setting minimum bids for your items/lots. Your items will likely not sell if set to high. Generally, dealers will pay no more than 50% to 80% of retail for numismatic items.
